REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on August 7, 2017 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, October 25, 2017 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Team Washington, Inc. d/b/a Domino's Pizza, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle U § 513.1(c), and pursuant to Subtitle X, Chapter 10, for a variance from the use conditions of Subtitle U § 513.1(c)(1), to establish a fast food and food delivery establishment in the MU-27 and R-13 zones at premises 2330 Wisconsin Avenue N.W. (Square 1300, Lot 815).
