An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on October 18, 2017 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, December 20, 2017 at 9:30 am**, at the Jerrily R. Application of Mark and Cynthia Moyer, pursuant to 11 DCMR Subtitle X, Chapter 10, for variances from the floor area ratio requirements of Subtitle F § 302.1 and the non-conforming structure requirements of Subtitle C § 202.2, to construct a rear attic dormer in an existing one-family dwelling in the RA-2 at premises 2517 Q Street N.W. (Square 1287, Lot 820).
