Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, February 6, 2019 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of The 3323 P Street Trust, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle D § 5201 from the nonconforming structure requirements of Subtitle C § 202.2, to construct rear shed dormer on the fourth story of an existing, detached principal dwelling unit in the R-20 Zone at premises 3323 P Street N.W. (Square 1254, Lot 223).
