If you do not have the requisite number of copies you can reproduce copies on an office printer in the Office of Zoning located across the hall. Please remember to collate each set of copies.

The order of procedures for special exceptions, variances, and appeals are also listed as you come walking into the door. The record shall be closed at the conclusion of each case except for any material specifically requested by the Board.

The Board and the Staff will specify at the end of the hearing exactly what is expected and the date when the persons must submit the evidence to the Office of Zoning. After the record is closed no other information shall be accepted by the Board.

The Board's agenda includes cases set for decision. After the Board adjourns the Office of Zoning in consultation with myself will determine whether a full or summary order may be issued.

A full order is required when the decision is adverse to a party, including an affected ANC. A full order may also be needed if the Board's decision differs from the Office of Planning's recommendation.

Although the Board favors the use of summary orders whenever possible an applicant may not request the Board to issue such an order.

The District of Columbia Administrative Procedures

Act requires that the public hearing on each case be held in

the open before the public pursuant to Section 405(b) and 406

of that Act.

The Board may, consistent with its rules of procedures and the Act, enter into a closed meeting on a case for purposes of seeking legal counsel on a case pursuant to D.C. Official Code Section 2-575(b)(4) and/or deliberating on a case pursuant to D.C. Official Code Section 2-575(b)(13) but only after providing the necessary public notice and in the case of an emergency closed meeting after taking a roll call vote.

The decision of the Board in cases must be based exclusively on the public record. To avoid any appearance to the contrary the Board requests that persons present not engage the members of the Board in conversation.

Please turn off all beepers and cell phones at this time so as not to disrupt the proceedings. Preliminary

matters are those which relate to whether a case will or should be heard today, such as request for a postponement, continuance, or withdraw, or whether proper and adequate notice for the hearing has been given.

If you are not prepared to go forward with the case today or if you believe that the Board should not proceed now is the time to raise such a matter. Mr. Secretary, do we have any preliminary matters?

MR. MOY: Good morning, Mr. Chairman, Members of the Board. I do have additional information regarding cases scheduled for today's docket.

First, Case Application Number 19898 of Michael Silvestro has been postponed/rescheduled to February 6, 2019, Application Number 19899 of Christopher Turner and Elizabeth Repko postponed/rescheduled to March 6, 2019, Application Number 19872 of Rupsha, R-U-P-S-H-A, 2011, LLC, has been postponed/rescheduled to February 13, 2019, and Application Number 19896 of Adams Morgan Friends and Allies postponed/rescheduled to March 6, 2019.

Other than that, Mr. Chairman, there are some other matters, but the Board can address those when I call the case.

MR. MOY: Good morning. Do you solemnly swear or affirm that the testimony you are about to present in this preceding is the truth, whole truth, and nothing but the truth?

(Off microphone comments)

MR. MOY: Ladies and gentlemen, you may consider yourselves under oath.

CHAIRMAN HILL: Okay. Good morning, everybody. We are going to be working through this day in a slower way than, or in a different way than I had initially thought. There is quite a few people that are sick on the Board and then the furlough has ended up affecting the Board in terms of some people that are able to participate.

So the first case I believe, Mr. Moy, and I don't know if you want to call it for decision and we'll talk about it.

MR. MOY: Yes, thank you, Mr. Chairman. So I will read this for the record. This is the one case for decision making, which is Application Number 19823 of Wisconsin Avenue Baptist Church, caption advertised for special exceptions under the use requirements, Subtitle U, Section 203.1(f) and under Subtitle C, Section 1402, from the retaining wall requirements of Subtitle C, 1401.3(c), and pursuant Subtitle Χ, Chapter 10, for variances from the

limitations of Subtitle D, Section 303.1, lot occupancy requirements of Subtitle D, Section 304.1, and from the side yard requirements of Subtitle D, Section 307.1, to construct a new four-story church and continuing care retirement facility, R-1-B Zone, at 3920 Alton Place, N.W., Square 1779, Lot 14.

CHAIRMAN HILL: Okay. Thank you, Mr. Moy. So, fellow Board Members, I guess this was set on the meeting agenda for deliberations today, but, unfortunately we don't have a quorum for this particular application and so I know that we are going to have also -- I guess we are off next week due to the Martin Luther King, Jr., holiday, and then the following week there is a conflict I know with another board member, and so, Mr. Moy, I think the week after that we could set this for deliberations again, and if you could tell me what date that is.

MR. MOY: Yes, sir. That would be February 6th.

CHAIRMAN HILL: Okay. So we'll go ahead and move
that to February 6th, unless anyone on the Board has any
other objections to that, and so we'll go ahead and do that
Mr. Moy. So that's the end of our hearing cases for today.
