An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on April 4, 2019 through the Interactive Zoning Information System (IZIS).

Application of Clementine Thomas and Sasaun Vasfi, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle D § 5201 from the rear yard setback requirements of Subtitle D § 1306.1, to construct a rear addition to an existing, detached principal dwelling in the R-21 Zone at premises 5011 Garfield Street N.W. (Square 1426, Lot 864).
