Dear Mr. Fredrick Hill, \$

We live directly behind the Buchanan Estate at 4220 Nebraska Ave, site of the proposed River School Relocation. We greatly admire The River School (TRS) which by all counts is an impressive institution not only for its educational program but also for its

accomplished distinction of supporting children and the community who suffer from hearing loss. We don't have an issue with a school relocating to the property per se but we do have the following concerns:

We have attended most of the public meetings, presentations and reviewed documents submitted as part of its BZA application. While TRS has attempted to be responsive to neighborhood concerns we note the following:

### First,

- Nebraska Ave is a major transit artery in Ward 3 and Tenleytown;
- The only entrance to the property is south bound on Nebraska;
- Based on demographic information provided by TRS to Matt Cohen on 2/22/21 by Sherry Rutherford of Equity Real Estate, the majority of students live south of the proposed relocation which will require vehicles to travel north, up and around Tenley-circle in order to change directions south to arrive at the property; or
- If vehicles want to avoid Tenleycircle, vehicles
  will travel up through AU/Tenleytown
  neighborhood, most likely Van Ness, Warren or
  Yuma to 42nd/Warren to take a right on
  Nebraska, the only other access point other
  than Tenleycircle to access the entrance
  southbound on Nebraska; and
- 42nd Street from both Van Ness and Yuma to Warren are not straight through-puts and include curves and mini traffic circles which impedes a constant flow of vehicles.

Additionally, in terms of traffic mitigation, we don't understand how a left hand traffic signal eastbound at Nebraska/Van Ness which will then result in northbound traffic on Nebraska or eliminating parking westbound on Van Ness between 41st and Nebraska will mitigate consequential and or TRS traffic as proposed.

The factors above, and that 46% of TRS students reside in VA & MD and 30% in zip codes other than 20016, makes us concerned with the viability to its CTR.

### Second,

While is not uncommon for data to be refined and updated over the course of a project, as noted above, on 2/22/21 Sherry Rutherford of Equity Real Estate

responded to a request from Matt Cohen as to the demographics of TRS for the following was provided:

However the TRS website currently

https://riverschool.net/wpcontent/uploads/2021/05/The-River-School-Project-Summary 5.04.2021.pdf

discloses that 44% of its current students live in the 20016 zip code. 48/201= 24% not 44%. While this appears to be a typo, this mistake and the lack of public disclosure of student demographic detail gives us pause, considering also its statements that its DC students will regularly be walking and biking considering the the young age of its student population and current zip codes.

It is also unclear how current student enrollment by zip code as provided above reconciles to the Comprehensive Transportation Report (CTR) filed with the BZA on 9/15/21. Figure 11B - Student Zip Code Locations, Page A-31 of the CTR discloses 20016 with 33 out to a grand total of 144. It would be helpful to understand how the CTR student enrollment/zip code locations reconciles to its current enrollment.

And finally, given the size of the proposed development, demographics of the student population, low walkability and use of public transportation (primarily due to the age of the children and addresses) for the majority of the student population and challenging exiting traffic issues on Nebraska/Van Ness & 42nd Street make it very difficult to support.

#### Commissioner Cohen,

I am writing in response to your e-mail to Allison Prince regarding the River School. With respect to student enrollment, 108 (54%) of the 201 currently-enrolled students reside in the District of Columbia. Of those 108 children, 48 (44%) live in zip code 20016, 28 (26%) live in 20007, 8 (7%) live in 20008, and 7 (6%) live in 20015. Of the remaining enrolled students who are not DC residents, 48 (24%) reside in Maryland and 45 (22%) reside in Virginia.

As noted at the ANC meeting, the River School's inclusive program is made of up of approximately 18% children with hearing loss, and 42% of River School's student body are children from diverse backgrounds. In addition, 24% of students receive financial assistance.

Our team is currently working to address the other issues raised at last week's meeting, and we look forward to sharing that information with you shortly. In the meantime, if you have any additional questions, please let us know.

I hope that you are well. Thank you for attending last month's ANC3E meeting with your client.

You will recall that at the meeting, I asked for a rough breakdown of residences (by state) of the student body currently attending The River School. To be frank, I was quite surprised that Ms. Mellon could not answer the question, or even provide some ballpark figures to the Commission. I believe that the answer was that the majority of students reside within the District, as opposed to Virginia or Maryland.
