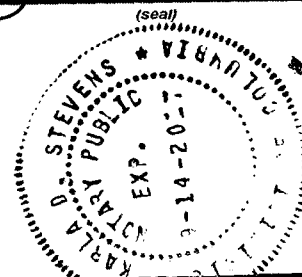

The aerial PL33 site consists of approximately 33 acres of land area and is generally bounded by 2nd Street to the west, 1st Street to the east, Virginia Avenue to the north, and M Street to the south. All of the southeast quadrant of the Township (the "PL33 Area"). The PL33 Area is within the boundaries of Arlington Neighborhoods and is zoned R-1C. The requested modification will increase the approved lot number of 377 lots from 377 lots to 400 lots, or an increase of 23 lots, or an increase of 6.6% of the total lots in the PL33 Area and 12 ACC units from 300 ACC units to 312 ACC units or 4.0% of the total lots in the PL33 Area. The requested modification will provide 305 ACC units in the PL33 Area and 312 ACC units on all other lots. The requested modification is not a change of use of the property.

The public hearing will be conducted in accordance with the variances provisions of the Zoning Regulations. 11 NCMB 3 622.

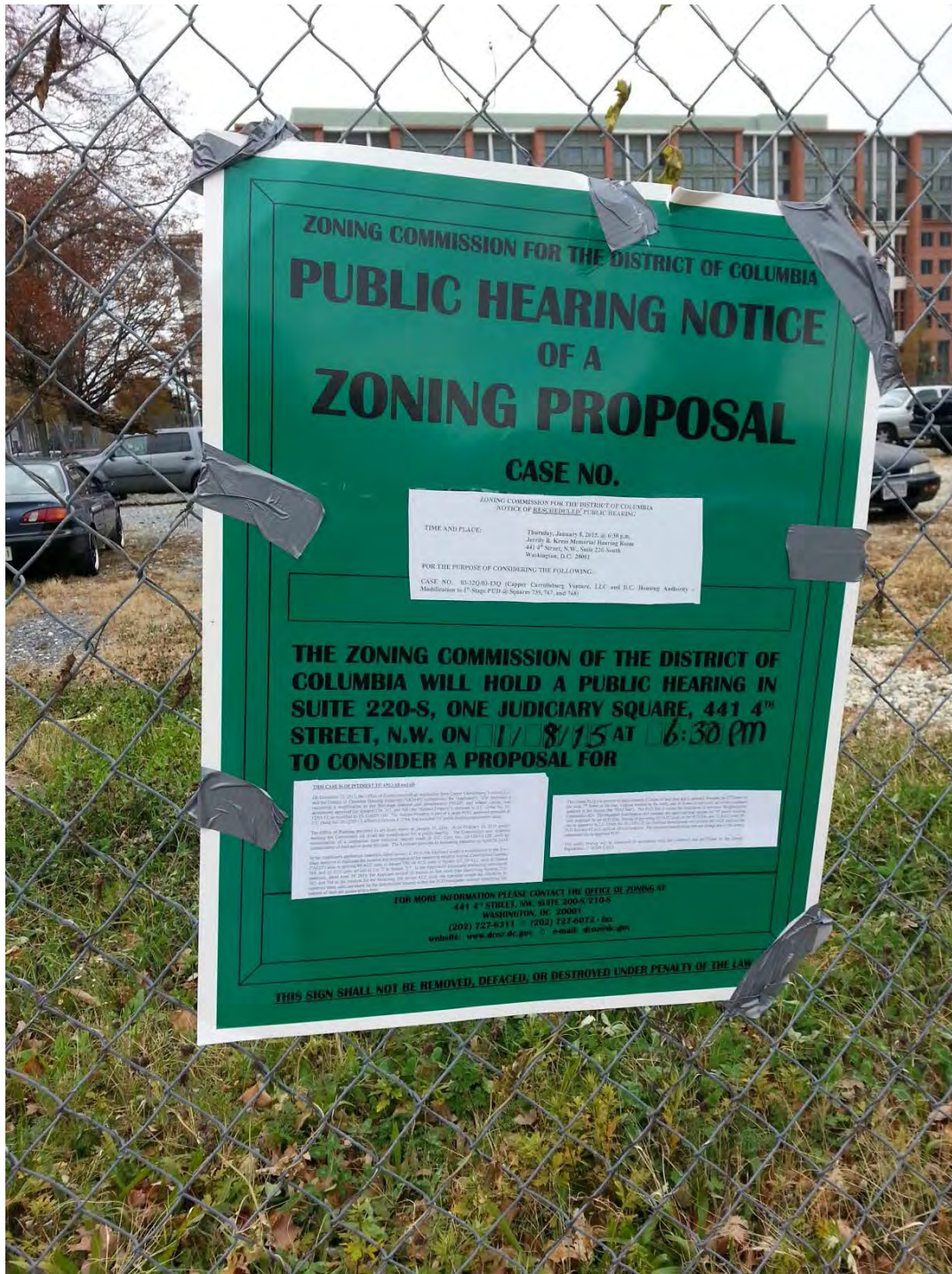
