Dear Neighbors:

This past Tuesday, February 19th, there was a Committee of the Whole meeting where, among other items, the committee considered.

- The Nuisance Properties Abatement Reform and Real Property Classification Amendment Act of 2008, Bill 17-0086, which passed unanimously and will go on to the March 4th legislative session for a first reading. This bill will eliminate the duplicate roles of DCRA and the Office of Tax and Revenue when determining whether a property is vacant and speed up the process by which a property can be declared vacant. It also doubles the vacant property tax rate from \$5 per \$100 of assessed value to \$10 per \$100 of assessed value.
- The Pesticide Consumer Notification Amendment Act of 2007, Bill 17-0493 passed the Committee of the Whole and will go on to the March 4th legislative session for a first reading. This bill will require pesticide applicators to provide information to prospective customers and residents concerning the type of pesticide to be used and provide safety information concerning that pesticide.

I was pleased to participate in the blood pressure screening this week offered by the American Heart Association as part of their February Heart Month activities. The John A. Wilson Building has been illuminated in red throughout the month of February to remind women about the risk of heart disease and to encourage them to control their risk factors. Women in the District of Columbia have the highest rates of uncontrolled hypertension in the nation, according to the American Heart Association. "I encourage everyone to get their blood pressure taken frequently and if they need medication to be sure to take it with regularity," said Councilmember Bowser.

The Takoma Aquatics Center at 300 Van Buren Street, NW is offering a new aquatic exercise class tailored to promote wellness for individuals with physical disabilities. The class will begin on Monday, March 3, 2008 and will be held on Monday & Wednesday mornings from 10:00am to 11:00am for 8 weeks – 16 classes. Sean Link, the Site Manager of the Takoma Aquatics Center designed the class and will be instructing it also. This class takes advantage of water's natural buoyancy to increase participants' mobility, flexibility, strength, and endurance by working through a range of shallow water exercises and stretches. Summary of the Upper Georgia Avenue Development Plan and relocation of Engine Company #22 – February 21 meeting

Councilmember Muriel Bowser and the DC Office of Planning hosted a meeting to update the community about the relocation of Engine Company #22 and the Upper Georgia Avenue Land Development Plan. Engine Company #22 is currently located at 5760 Georgia Avenue, NW and 11 firefighters and paramedics support calls for service from Petworth, Brightwood, Brightwood Park, Shepherd Park, Takoma, North Portal Estates and Colonial Village. There is a need to relocate the fire station to improve response times to the northern most portions of Ward 4.

Councilmember Bowser, the Office of Planning, DC Fire/EMS and the Office of the Deputy Mayor for Economic Development are all working closely with the Department of the Army and the Walter Reed Army Medical Center (WRAMC) officials to explore relocating Engine Company #22 to the corner of Fern Street and Georgia Avenue, NW, on the WRAMC property. This location is one mile north of the current location. As has been discussed, the transition at the WRAMC property will be completed in the Summer of 2011. The Federal agencies have affirmed "in

concept" their commitment to working with DC government to move the fire house to the grounds of the WRAMC but the details of the agreement have not been finalized.

The draft plan of the Upper Georgia Avenue Land Development Plan was released for public comment in the Summer of 2007. The Office of Planning received more than 20 public comments as well as oral testimony during the Mayor's hearing in July 2007. They are currently revising the plan for submission to the DC Council in April 2008 and meeting with ANC's and community associations to discuss the changes made to the draft plan. The public will have another opportunity to comment on the plan at an upcoming DC Council hearing after the plan is submitted.
