Dear Chairperson Moldenhauer:

Pursuant to a Letter Agreement dated May 4, 2010, the Parties in the above captioned matter agreed that, upon completion of certain improvements to Francis Field and the related streetscape improvements called for in Conditions 10(b) and 10(c) of the Zoning Commission Order No. 06-35 (the "Order"), the Friends of Francis Field ("FFF") and Foggy Bottom and West End Advisory Neighborhood Commission ("ANC 2A") would withdraw BZA Appeal No. 18029 (the "Appeal") and related challenges to the Order.

The improvements to Francis Field and the related streetscape improvements have been completed to the satisfaction of FFF and ANC 2A. Therefore, please accept this letter as confirmation that the Parties have amicably resolved the disputes related to the Appeal and Order, and the FFF and ANC 2A hereby withdraw the Appeal and have no further challenge to the issuance of certificates of occupancy related to the building located at 1255 25th Street NW, Washington, DC.

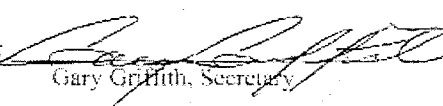
