Application No. 18159 of Alan and Faye Hegburg, pursuant to 11 DCMR § 3104.1, for a special exception to allow an addition to an existing one-family detached dwelling under section 223, not meeting the side yard (section 405) requirements in the R-5-B District at premises 627 G Street, S.E. (Square 858, Lot 152).¹

SUMMARY ORDER

SELF CERTIFIED

The zoning relief requested in this case was self-certified, pursuant to 11 DCMR § 3113.2. (Exhibit 6.)

The Board provided proper and timely notice of the public hearing on this application by publication in the *D.C. Register* and by mail to Advisory Neighborhood Commission (“ANC”) 6B and to owners of property within 200 feet of the site. The site of this application is located within the jurisdiction of ANC 6B, which is automatically a party to this application. On January 18, 2011, ANC 6B submitted its report, dated January 12, 2011, indicating that at a duly noticed and regularly scheduled public meeting on January 11, 2011, at which a quorum was present, ANC 6B voted 6-2-2 to approve the pending application. (Exhibit 25.) The Office of Planning (“OP”) submitted a timely report recommending approval of the application.² (Exhibit 29.) Letters of support were submitted by owners of adjacent properties, namely Gregg and Kim Diffendal, 629 G Street, S.E. and David Jonathan Taylor, 621/623 G Street, S.E. (Exhibits 26 and 28.)

¹ The caption was amended to reflect that this is a single-family detached, rather than a semi-detached, dwelling.

² According to the OP report, the Historic Preservation Review Board reviewed and approved the plans for the proposed addition as the property is within the Capitol Hill historic district. (Exhibit 29.)

As directed by 11 DCMR § 3119.2, the Board has required the Applicant to satisfy the burden of proving the elements that are necessary to establish the case pursuant to § 3104.1, for a special exception under § 223, not meeting the side yard (§ 405) requirements. No parties appeared at the public hearing in opposition to this application. Accordingly, a decision by the Board to grant this application would not be adverse to any party.

Based upon the record before the Board and having given great weight to the ANC and OP reports, the Board concludes that the Applicant has met the burden of proof, pursuant to 11 DCMR §§ 3104.1 and 223, that the requested relief can be granted as being in harmony with the general purpose and intent of the Zoning Regulations and Map. The Board further concludes that granting the requested relief will not tend to affect adversely the use of neighboring property in accordance with the Zoning Regulations and Map.

Pursuant to 11 DCMR § 3100.5, the Board has determined to waive the requirement of 11 DCMR § 3125.3, that the order of the Board be accompanied by findings of fact and conclusions of law. It is therefore **ORDERED** that this application (pursuant to Exhibit 9 – Plans) be **GRANTED**.
