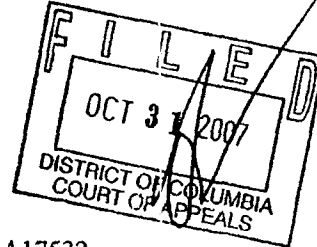

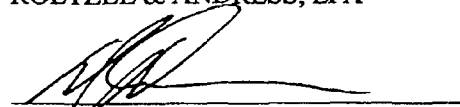
**MOTION TO DISMISS**
