Dear Advisory Neighborhood Commission 6A:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

**Application of Vanessa Manchester**, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a special exception to construct a free standing garage addition serving an existing one-family row dwelling under section 223, not meeting the lot occupancy (403) requirements, and a variance from the accessory structure height and story limitations under subsection 2500.4, in the R-4 District at premises 1231 F Street, N.E. (Square 1007, Lot 113).

The hearing will be held on Tuesday, September 13, 2011, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.

You are advised that 11 DCMR Section 3115.1 sets out certain requirements related to reports of ANCs, and specifically that Section 3115 requires that the written report of the ANC be filed with the Board at least seven days in advance of the hearing.
