This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following appeal that is located within the boundaries of your ANC area:

Appeal of Advisory Neighborhood Commission 1C, pursuant to 11 DCMR §§ 3100 and 3101, from a May 13, 2011, decision by the Zoning Administrator, Department of Consumer and Regulatory Affairs, to issue a certificate of occupancy (CO54337) allowing a fast food establishment (Peking Garden Carry Out) and food delivery in the C-2-A District at premises 2008 18th Street, N.W. (Square 2555, Lot 47).

The hearing will be held on Tuesday, October 25, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This appeal will be heard between 1:00 p.m. and 6:00 p.m.
