This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following appeal that is located within the boundaries of your ANC area:

Appeal of Walter Parrs, pursuant to 11 DCMR §§ 3100 and 3101, from an April 8, 2011, decision by the Zoning Administrator, Department of Consumer and Regulatory Affairs, to issue a building permit allowing the construction of an elevator or material lift in the C-2-A District in the rear of premises 3307 M Street, N.W. (Square 1205, Lot 79).

The hearing will be held on Tuesday, November 1, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This appeal will be heard between 1:00 p.m. and 6:00 p.m.

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing.
