This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

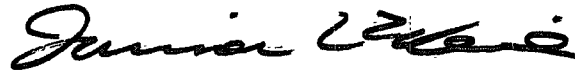
Application of Stephanie and John Lester, pursuant to 11 DCMR §§ 1202.1, 3104.1 and 3103.2, for a special exception under section 223, to allow a two story addition to an existing one-family row dwelling and to construct a two story accessory garage not meeting the lot occupancy (section 403) requirements, a special exception from the accessory building one-story height limitation under subsection 2500.4, and a variance from the building lot control restrictions to allow apartment use of the second story of the proposed two story accessory garage under subsection 2516.1, in the CAP/R-4 District at premises 117 C Street, S.E. (Square 733, Lot 23).

The hearing will be held on Tuesday, October 25, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.

You are advised that 11 DCMR Section 3115.1 sets out certain requirements related to reports of ANCs, and specifically that Section 3115 requires that the written report of the ANC be filed with the Board at least seven days in advance of the hearing.
