This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Little Deli Delicatessen, Trading as Chuck's Deli, pursuant to 11 DCMR § 3103.2, for a variance from the use provisions to allow a delicatessen on the first floor (lobby) of an existing apartment house under subsection 350.4, in the DD/R-5-E District at premises 1221 Massachusetts Avenue, N.W. (Square 282, Lot 44).

The hearing will be held on Tuesday, November 15, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.
