Dear Advisory Neighborhood Commission 6B:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Potomac Avenue LLC pursuant to 11 DCMR §§ 3103.2 and 3104.1, for a special exception for a change of nonconforming use allowing a coffee shop on the first floor under subsection 2003.1, and a variance from the use provisions to allow a pet supply store on the second floor of an existing two story building under subsection 350.1, in the R-5-B District, at premises 1200 Potomac Avenue, S.E. (Square 1021, Lot 34).

The hearing will be held on Tuesday, November 15, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.
