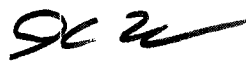

Pursuant to D.C. Official Code § 1-309.10 (b), the Board of Zoning Adjustment (“BZA”) hereby gives notice that the above-mentioned application, the subject property of which is located within the boundaries of your Advisory Neighborhood Commission, was filed with the BZA on August 1, 2011. A copy of the application is attached.

The application has been tentatively placed on the BZA’s Expedited Review Calendar for a decision without a public hearing at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001 on October 4, 2011, at 9:30 a.m. This is also the location of the Office of Zoning.

The ANC and the affected Single Member District may file a written request that the application be removed from the Expedited Review Calendar and heard by the BZA in accordance with 11 DCMR § 3117. Such a request must be filed with the Office of Zoning no later than fourteen (14) days prior to the date that the expedited review is scheduled, and must be accompanied by:

- (1) A statement indicating that an ANC representative will appear as a witness at the hearing; and
- (2) A summary of the testimony to be given at that time.

The BZA Chairperson may deny a request to remove an application if the proffered testimony is irrelevant.

Pursuant to 11 DCMR §§ 3012.6 and 3115.2, the Zoning Commission and Board of Zoning Adjustment shall give "*great weight*" to the written report of the affected Advisory Neighborhood Commission (ANC), as required by the Comprehensive Advisory Neighborhood Commissions Reform Amendment Act of 2000.

1. All ANC reports shall be made pursuant to this form. If additional space is necessary, use separate sheets of 8½" x 11" paper to complete the form.
2. Present this form and supporting documents to the Office of Zoning at 441 4<sup>th</sup> Street, N.W., Suite 200-S, Washington, D.C. 20001.
3. Submission deadlines are as follows:

**For Zoning Commission:**

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing, if they wish to participate in a contested case under § 3022.
- b. ANCs may file this form as long as the case record is open, if they wish to participate in a rulemaking case under § 3021.

**For Board of Zoning Adjustment:**

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing.
