This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of RP MRP 900 G LLC, pursuant to 11 DCMR §§ 3104.1, and 3103.2, for a special exception from the roof structure requirements under section 777, 400.7, and 411.5, variances from the loading requirements under sections 2201.1, and 2203.2, and a variance from the open court requirements under section 776.1, to allow a new office building with ground floor retail in the DD/C-4 District at premises 624 9th Street, N.W. (Square 376, Lot 68).

The hearing will be held on Tuesday, November 29, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
