This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Kathryn Kross, pursuant to 11 DCMR § 3104.1, for a special exception to allow a front porch addition to an existing one-family row dwelling under section 223, not meeting the lot occupancy requirements (section 403), and the nonconforming structure requirements (subsection 2001.3) in the R-5-B District at premises 1908 Belmont Road, N.W. (Square 2539, Lot 207).

The hearing will be held on Tuesday, November 29, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
