This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of the Association of American Medical Colleges, pursuant to 11 DCMR §§ 3104.1, and 3103.2, for special exception relief under sections 771.1, and 411.11, relating to penthouse setback requirements, and section 2108.1, relating to the minimum number of required parking spaces and for a variance from section 1701.7, relating to required setbacks for buildings fronting on Mount Vernon square, to construct a new office and retail building with below grade parking in the DD/C-2-C District at premises 611-627 K Street, N.W., and 616-640 New York Avenue, N.W. (Square 451, Lots 2,3,4, 31, 801, 806, 807, 810, 811, 820, 821, 824, 825, 826, and 830).

The hearing will be held on Tuesday, November 29, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
