This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of the International Monetary Fund, pursuant to 11 DCMR §§ 3104.1, and 3103.2, for a variance from the parking requirements under section 2101, and a special exception from the roof structure requirements under section 411, to permit the redevelopment of an existing apartment house in the DC/R-5-E District at premises 1250 New Hampshire Avenue, N.W. (Square 70, Lot 186).

The hearing will be held on Tuesday, December 13, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
