This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of AMGR 2055 L Owner LLC, pursuant to 11 DCMR §§ 3104.1, and 3103.2, for a variance from the parking requirements under section 2101, and a special exception from the rear yard requirements under section 774, to permit the expansion of an existing office and switch gear building through the acquisition of transferable development rights in the C-3-C District at premises 2055 L Street, N.W. (Square 100, Lots 121, 2005-2010).

The hearing will be held on Tuesday, November 29, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.
