


Dear Mr. Weinbaum:

At a properly noticed and with a quorum present at the Advisory Neighborhood Commission 4C meeting held on November 9, 2011, the 4C Commission voted unanimously to oppose BZA Application # 18286, application for variance under the provisions of DCMR Title 11, Section 201 to establish use in the R-1-B Zone. The motion to protest was presented by Commissioner Janet Myers, SMD 4C02, seconded, and passed unanimously by the 4C Commission based on requests from neighbors who strongly oppose the establishment of a catering and meal delivery business in a residential home.

Donna Gedeon located at 1204 Ingraham Street, NW (Square 2930, Lot 0074) has applied for a variance under the provisions of DCMR Title 11, Section 3103.2 to establish a catering and meal delivery business in the basement and a portion of the main level of this house.

Based on the foregoing, ANC 4C respectfully requests that the Board of Zoning Adjustment give great weight to the Commission's position to protest Application #18286 for variance to establish a catering and meal delivery business in a residential home.


