Dear Advisory Neighborhood Commission 2F:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of CAS Riegler Real Estate Development, pursuant to 11 DCMR §§ 3104.1, and 3103.2, for a variance from the lot occupancy requirements under subsection 772.1, a variance from the closed court requirements under section 776, a variance from the nonconforming structure provisions under subsection 2001.3, a variance from the street frontage limitations on eating/drinking establishments under subsection 1901.6, and a special exception from the rear yard provisions under subsection 774.2, for an addition to and conversion of an existing building to a mixed-use residential building with ground floor retail in the ARTS/C-3-A District at premises 1324 14th Street, N.W. (Square 211, Lot 32).

The hearing will be held on Tuesday, December 13, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.

You are advised that 11 DCMR Section 3115.1 sets out certain requirements related to reports of ANCs, and specifically that Section 3115 requires that the written report of the ANC be filed with the Board at least seven days in advance of the hearing.
