This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Scott and Diane Bassett, pursuant to 11 DCMR § 3104.1, for a special exception to allow an addition to an existing one-family semi-detached dwelling under section 223, not meeting the lot area and width requirements (section 401), lot occupancy requirements (section 403), side yard requirements (section 405) and the nonconforming structure requirements (subsection 2001.3) in the R-3 District at premises 3127 P Street, N.W. (Square 1270, Lot 12).

The hearing will be held on Tuesday, December 13, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing.
