This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Paul and Emily Thornell, pursuant to 11 DCMR § 3104.1, for a special exception to allow a rear addition to an existing one-family semi-detached dwelling under section 223, not meeting the lot occupancy (section 403), and rear yard (section 404) requirements in the R-2 District at premises 3011 Ordway Street, N.W. (Square 2067, Lot 76).

The hearing will be held on Tuesday, January 17, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
