Application of Steve and Elizabeth Allenbach, pursuant to 11 DCMR § 3104.1, for a special exception to allow additions to an existing one-family row dwelling under section 223, not meeting the lot occupancy (section 403) requirements in the R-4 District at premises 1414 A Street, N.E.
