Dear Advisory Neighborhood Commission 6C:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Mt. Olive Baptist Church, pursuant to 11 DCMR §§ 3104.1 and 3103.2, for a special exception for a child development center (50 children ages 6 years and under and 12 staff) under section 205, a variance from the lot occupancy requirements under section 403, a variance from the nonconforming structure provisions under subsection 2001.3, and a variance from the off-street parking requirements under subsection 2101.1, to construct an addition to an existing church structure in the R-4 District at premises 1140 6th Street, N.E. (Square 829, Lot 65).

The hearing will be held on Tuesday, December 20, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.

You are advised that 11 DCMR Section 3115.1 sets out certain requirements related to reports of ANCs, and specifically that Section 3115 requires that the written report of the ANC be filed with the Board at least seven days in advance of the hearing. Form 129 – Advisory Neighborhood Commission (ANC) Report, which is enclosed for your convenience, is the preferred mechanism to complete this report. In the alternative, you can review Section 3115, which states the required information for the written report. 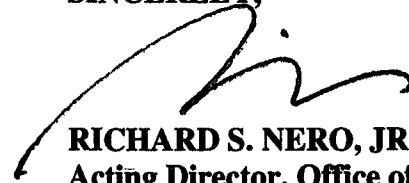
