This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Edward C. Mazique Parent Child Center, Inc., pursuant to 11 DCMR § 3104.1, for a special exception to allow a child development center (205 children, ages 6 weeks to 5 years, and 85 staff) under section 205, in the R-4 District at premises 1719-21 13th Street, N.W. (Square 276, Lot 132).

The hearing will be held on Tuesday, January 17, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.

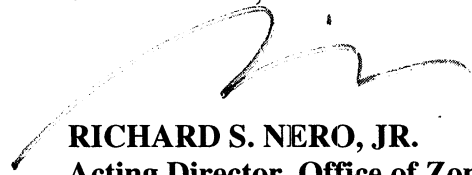
