Application No. 15117 of the Phyllis Wheatley YWCA, pursuant to 11 DCMR 3108.1, for a special exception under Section 205 for the proposed construction of a child development center for 160 children and 85 staff and other employees in an R-4 District at premises 1719 and 1721 -13th Street, N.W., (Square 276, Lot 806).

SUMMARY ORDER

The Board duly provided timely notice of the public hearing on this application, by publication in the D.C. Register, and by mail to ANC 2C and to owners of property within 200 feet of the site.

The site of the application is located in Advisory Neighborhood Commission ("ANC") 2C. ANC 2C, which is automatically a party to the application, by letter dated July 19, 1989, submitted written issues and concerns in support of the application.

As directed by 11 DCMR 3324.2, the Board has required the applicant to satisfy the burden of proving the elements which are necessary to establish the case for a special exception pursuant to 11 DCMR 205. No person or entity appeared at the hearing or otherwise requested to participate as a party in this proceeding. Accordingly, a decision by the Board to grant this application would not be adverse to any party.

Based upon the record before the Board, the Board concludes that the applicant has met the burden of proof, pursuant to 11 DCMR 3108, and that the requested relief can be granted without substantial detriment to the public good and without substantially impairing the intent, purpose, and integrity of the zone plan as embodied in the Zoning Regulations and maps. It is therefore ORDERED that the application is GRANTED, SUBJECT to the following CONDITIONS:

1. The number of students shall not exceed 160.
The number of staff shall not exceed 85.

The hours of operation shall not exceed from 7:00 A.M. to 6:00 P.M., Monday through Friday.

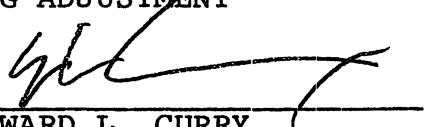
3. The applicant shall provide 33 on-site parking spaces.
4. Construction shall be in accordance with the plans marked as Exhibit No. 9 as modified by Exhibit No. 29 of the record. 2011 AUG 23 AM 10:19
5. The applicant shall have flexibility to modify design features of the project in cooperation with the community's Mazaque Architectural Design Committee regarding the issues outlined in Exhibit No. 42 of the record.

Pursuant to 11 DCMR 3301.1, the Board has determined to waive the requirement of 11 DCMR 3331.3 that the order of the Board be accompanied by findings of fact and conclusions of law. The waiver will not prejudice the rights of any party, and is not prohibited by law.
