This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

**Application of Daniel T. Merlis**, pursuant to 11 DCMR § 3104.1, for a special exception to allow a rear deck addition to a one-family detached dwelling under section 223, not meeting the rear yard (sections 404, and 2503.1) requirements in a R-2 District at premises 3825 Morrison Street, N.W. (Square 1859, Lot 62).

The hearing will be held on Tuesday, January 17, 2012, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
