Application of Daniel T. Merlis, pursuant to 11 DCMR § 3104.1, for a special exception to allow a rear deck addition to a one-family detached dwelling under section 223, not meeting the rear yard (sections 404, and 2503.1) requirements in a R-2 District at premises 3825 Morrison Street, N.W. (Square 1859, Lot 62).

The sign and the affidavit should be picked up from the Office of Zoning, Suite 200 South, 441 4th Street, N.W., Washington, D.C. 20001. Please call the Office of Zoning in advance to order your sign(s) to assure that the sign(s) will be ready when you come to pick them up.

You should be aware that letters and other documents may be submitted to the Board by other individuals, organizations and government agencies both in support of and in opposition to your application. At least one week prior to the public hearing, you should review the file in your application so that you are prepared to respond to any issues that may be raised regarding your case.
