This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Elena Loukoianova, pursuant to 11 DCMR § 3103.2, for variance from the lot area requirements under subsection 401.3, to convert a flat (two-unit dwelling) to a three (3) unit apartment building, in the R-4 District at premises 1633 13th Street, N.W. (Square 277, Lot 7).

The hearing will be held on Tuesday, January 17, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.

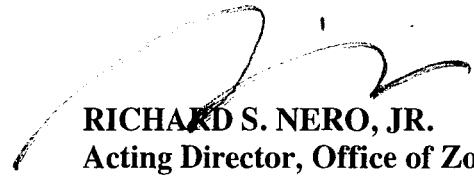
