I am writing to follow up on the above-referenced FOIA request. I understand that DCRA has invoked an extension, as indicated in Mr. Williams' e-mail below, but I would like to know whether there is any possibility of delivering the documents within the basic time period for response (15 business days) or at least by the end of this week, as I understand the permit in question has now been issued and some of the requested documents are, at least in theory, publicly available through the file room. The application documents, zoning computations, and correspondence, however, are not available through the file room, hence the FOIA request.
