This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Bozzuto Homes, Inc., on behalf of Meridian Hill Baptist Church, pursuant to 11 DCMR § 3103.2, for a variance from the rear yard requirements under subsection 404.1, and a variance from the court width requirements under subsection 406.1, to allow an addition to, and renovation of, an existing building for residential use in the R-5-D District at premises 3146 16th Street, N.W. (Square 2595, Lot 831).

The hearing will be held on Tuesday, February 28, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
