This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of KB Developers LLC and Rupp OB LLC, pursuant to 11 DCMR § 3103.2, for a variance from the lot width and area requirements under subsection 401.3, and a variance from the lot occupancy requirements under subsection 403.2, to allow the construction of three one-family row dwellings on alley lots in the R-4 District at premises 1321 Naylor Court, N.W. (Square 367, Lot 862).

The hearing will be held on Tuesday, March 6, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
