This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Jose Silva, pursuant to 11 DCMR § 3104.1, for a special exception for a one story rear addition to an existing one-family detached dwelling under section 223, not meeting the lot occupancy (section 403), rear yard (section 404), and nonconforming structure (subsection 2001.3) requirements in the R-4 District at premises 4029 Gault Place, N.E. (Square 5077, Lot 39).

The hearing will be held on Tuesday, February 28, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.

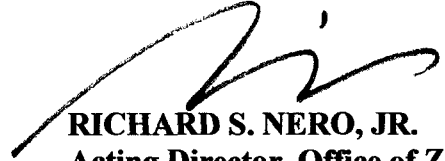
