Application of Robert M. Holland, pursuant to 11 DCMR § 3104.1, for a special exception to allow a fifty five (55) space accessory parking lot under section 214, in the R-2 District, at premises 3831 McKinley Street, N.W. (Square 1860, Lots 5,6,7,17 and 18).

The property involved in this application is located within the boundaries of Advisory Neighborhood Commission 3G. This application will be heard between 9:30 a.m. and 12:00 p.m.

The posted notice must also be checked at least once every five days, and replaced when necessary. An affidavit concerning the original posting of the sign must be filed with the Board at least 5 days prior to the hearing. The sign and the affidavit should be picked up from the Office of Zoning, Suite 200 South, 441 4th Street, N.W., Washington, D.C. 20001. Please call the Office of Zoning in advance to order your sign(s) to assure that the sign(s) will be ready when you come to pick them up.

You should be aware that letters and other documents may be submitted to the Board by other individuals, organizations and government agencies both in support of and in opposition to your application. At least one week prior to the public hearing, you should review the file in your application so that you are prepared to respond to any issues that may be raised regarding your case.
