This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Roane-Worsley LLC, pursuant to 11 DCMR § 3103.2, for variance to allow the conversion of a flat (two unit dwelling) to a three unit apartment house under subsection 401.3, in the R-4 District at premises 1337 Maryland Avenue, N.E. (Square 1028, Lot 35).

The hearing will be held on Tuesday, April 3, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.
