Application No. 17651 of Consortium Three-Judiciary Square LLC, pursuant to 11 DCMR § 3103.2, for a variance from the rear yard requirements under § 774 and pursuant to 11 DCMR § 3104.1, a special exception from the roof structure setback requirements under § 770.6(b) and roof structure uniform height requirements under § 411.5, to allow an addition to an existing building in the DD/C-2-C District at premises 704 3rd Street, N.W. (Square 529, Lots 802, 803, 845 and 847).

SUMMARY ORDER

SELF-CERTIFIED

The zoning relief requested in this case was self-certified, pursuant to 11 DCMR § 3113.2.

The Board provided proper and timely notice of the public hearing on this application by publication in the D.C. Register, and by mail to Advisory Neighborhood Commission (ANC) 6C and to owners of property within 200 feet of the site. The site of this application is located within the jurisdiction of ANC 6C, which is automatically a party to this application. ANC 6C submitted a report in support of the application. The Office of Planning (OP) also submitted a report in the application, which supported the granting of the relief requested. District Department of Transportation (DDOT) did not oppose the application.

As directed by 11 DCMR § 3119.2, the Board has required the Applicant to satisfy the burden of proving the elements that are necessary to establish the case pursuant to § 3103.2, for variance relief from §774, and pursuant to §§ 3104.1 and 411.11, for special exception relief from §§ 411.5 and 770.6(b). No parties appeared at the public hearing in opposition to this application. Accordingly, a decision by the Board to grant this application would not be adverse to any party.

As indicated above, this is an application for an expansion to the Canterbury (The Harrison) historic landmark. The Applicant represented that it would renovate the existing Canterbury building and construct an eleven story and 130 foot addition on the property with a rear yard and roof structure that would not be compliant under the Zoning Regulations.

Based upon the record before the Board and having given great weight to the ANC and OP reports filed in this case, the Board concludes that the Applicant has met the burden of proving under 11 DCMR § 3103.2 that there exists an exceptional or extraordinary situation or condition related to the property that creates a practical difficulty for the owner in complying with the Zoning Regulations, and that the relief can be granted without substantial detriment to the public good and without substantially impairing the intent, purpose, and integrity of the zone plan as embodied in the Zoning Regulations and Map.

Further, based upon the record before the Board and having given great weight to the OP and ANC reports, the Board concludes that the Applicant has met the burden of proof, pursuant to 11 DCMR §§ 3104.1 and 411.11, and that the requested relief can be granted as being in harmony with the general purpose and intent of the Zoning Regulations and Map. The Board further concludes that granting the requested relief will not tend to affect adversely the use of neighboring property in accordance with the Zoning Regulations and Map.

At the time of filing this Application, the Applicant filed for variance relief from the parking requirements under § 2101.1 and the loading requirements under § 2201.1. Since the Order for Zoning Commission Case No. 06-33, which will require additional parking to be provided for expansions of historic landmark structures, has not been published as of the date of this Order, the version of § 2100.5 that is in effect as of the date of this Order controls and no additional parking is required at the property for the expansion to the Canterbury historic landmark structure (See § 3202.6). In addition, the Applicant does not require the originally requested variance relief from the loading requirements under § 2201.1, since § 2200.5 exempts expansions to historic landmark structures from providing loading facilities.

Pursuant to 11 DCMR § 3100.5, the Board has determined to waive the requirement of 11 DCMR § 3125.3, that the order of the Board be accompanied by findings of fact and conclusions of law. It is therefore **ORDERED** that this application be **GRANTED**, **SUBJECT** to the following **CONDITION**:
