This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of The Fishing School, pursuant to 11 DCMR §§ 3104.1 and 3129.7, for a modification and a special exception approval of an expansion of an approved child development center (per BZA Order No. 18042) to include a new two-story building devoted to space for administrative use and parent workshop and activities use, at premises 4720 Meade Street, N.E. (Square 5160, Lot 817).

The hearing will be held on Tuesday, March 20, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.
