This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Louis Bell and Florence Jaumotte, pursuant to 11 DCMR § 3103.2, for variance to exceed the limitation on the number of stories under subsection 400.1, to allow the construction of a two story addition on an existing detached dwelling in the R-1-B District at premises 1415 Otis Street, N.E. (Square 4004, Lot 25).
