This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Ann Pina, pursuant to 11 DCMR § 3104.1, for a special exception to allow a two story rear addition to an existing one-family row dwelling under section 223, not meeting the lot occupancy (section 403), and court (section 406) requirements in the R-4 District at premises 1439 East Capitol Street, S.E. (Square 1058, Lot 44).

The hearing will be held on Tuesday, April 3, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
