This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Grant Barker, pursuant to 11 DCMR § 3103.2, for a variance from the minimum lot area requirements under subsection 401.3, to allow the conversion of an existing three (3) unit apartment house to a four (4) unit apartment house in the R-4 District at premises 821 Randolph Street, N.W. (Square 3027, Lot 85).
