This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Robert Burrows, pursuant to 11 DCMR § 3103.2, for a variance from the lot occupancy requirements under section 403, and the nonconforming structure provisions under subsection 2001.3, to allow a two story addition to an existing one-family dwelling in the R-1-B District at premises 4601 Western Avenue, N.W. (Square 1488, Lot 810).
