Application of Grace Evangelical Lutheran Church c/o Amazing Life Games Preschool, pursuant to 11 DCMR § 3104.1, for a special exception to allow a child development center (35 children and 5 staff) under section 205, in the R-1-B District at premises 4300 16th Street, N.W. (Square 2646, Lot 807).

The property involved in this application is located within the boundaries of Advisory Neighborhood Commission 4A. This application will be heard between 9:30 a.m. and 12:00 p.m.

The sign and the affidavit should be picked up from the Office of Zoning, Suite 200 South, 441 4th Street, N.W., Washington, D.C. 20001. Please call the Office of Zoning in advance to order your sign(s) to assure that the sign(s) will be ready when you come to pick them up.

You should be aware that letters and other documents may be submitted to the Board by other individuals, organizations and government agencies both in support of and in opposition to your application. At least one week prior to the public hearing, you should review the file in your application so that you are prepared to respond to any issues that may be raised regarding your case.
