This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Petit Scholars Early Learning Center, pursuant to 11 DCMR § 3104.1, for a special exception for a reduction in the number of required (subsection 2101.1) off-street parking spaces serving a child development center (35 children and 7 Staff) under subsection 2108.1, in the C-1 District at premises 2940 12th Street, N.E. (Square 3875, Lot 90).

The hearing will be held on Tuesday, April 17, 2012, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 1:00 p.m. and 6:00 p.m.

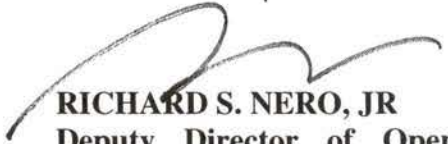
