Dear Advisory Neighborhood Commission 7D:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of M. Sikder, pursuant to 11 DCMR § 3103.2, for variances from the lot area and lot width requirements under subsection 401, and a variance from the side yard requirements under section 405, to allow the construction of a one-family detached dwelling in the R-2 District at premises 4209 Grant Street, N.E. (Square 5092, Lot 31).

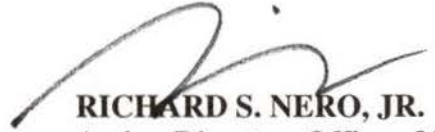

3. Submission deadlines are as follows:

For Zoning Commission:

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing, if they wish to participate in a contested case under § 3022.
- b. ANCs may file this form as long as the case record is open, if they wish to participate in a rulemaking case under § 3021.

For Board of Zoning Adjustment:

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing.
