This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of M. Sikder, pursuant to 11 DCMR § 3103.2, for variances from the lot area and lot width requirements under subsection 401, to allow the construction of a one-family detached dwelling in the R-1-B District at premises 2425 Franklin Street, N.E. (Square 4265, Lot 821).
